

End-User License Agreement (EULA) of Software Included within or in Connection with the Delivered WALZ products

This End-User License Agreement ("EULA") is a legal agreement between you and **Heinz Walz GmbH** (hereinafter referred to as "**WALZ**"). This EULA applies to "**Software Included Within or in Connection with Delivered WALZ products**" (hereinafter referred to as "**SOFTWARE**"). Our EULA is based on a draft created by "EULA Template" (<https://www.eulatemplate.com/>).

This EULA agreement governs your use of SOFTWARE obtained directly from WALZ or indirectly through a WALZ authorized reseller or distributor. Our Privacy Policy is defined on the WALZ website: <https://www.walz.com/company/privacy.html>.

Please read this EULA agreement carefully before completing the installation process and using the SOFTWARE.

If you are entering into this EULA agreement on behalf of a company or other legal entity, you represent and warrant that you have the authority to bind such entity and its affiliates to these terms and conditions. If you do not have such authority or if you do not agree with the terms and conditions of this EULA agreement, do not install or use the SOFTWARE, and you must not accept this EULA agreement.

This EULA agreement shall apply only to the SOFTWARE supplied by WALZ herewith regardless of whether other software is referred to or described herein. The terms also apply to any WALZ updates, supplements, Internet-based services, and support services for the SOFTWARE, unless other terms accompany those items on delivery. If so, those terms apply.

Liability

Direct or indirect harm to any individual or material related to the use of the SOFTWARE is liability of the end user.

License Grant

WALZ hereby grants you a personal, non-transferable, non-exclusive license to use the SOFTWARE on your devices in accordance with the terms of this EULA agreement.

You are permitted to load the Software on any device (for example PCs, laptops, mobiles and/or tablets) under your control. You are responsible for ensuring your device meets the minimum requirements of the SOFTWARE.

You are not permitted to:

- Edit, alter, modify, adapt, translate or otherwise change the whole or any part of the SOFTWARE nor permit the whole or any part of the SOFTWARE to be combined with or become incorporated in any other software, nor decompile, disassemble or reverse engineer the SOFTWARE or attempt to do any such things
- Distribute, resell or otherwise use the SOFTWARE for any commercial purpose
- Allow any third party to use the SOFTWARE on behalf of or for the benefit of any third party
- Use the SOFTWARE in any way which breaches any applicable local, national or international law
- Use the SOFTWARE for any purpose that WALZ considers is a breach of this EULA agreement

Intellectual Property and Ownership

WALZ shall at all times retain ownership of the SOFTWARE as originally downloaded by you and all subsequent downloads of the SOFTWARE by you. The SOFTWARE (and the copyright, and other intellectual property rights of whatever nature in the Software, including any modifications made thereto) are and shall remain the property of WALZ.

WALZ reserves the right to grant licenses to use the SOFTWARE to third parties.

Termination

This EULA agreement is effective from the date you first use the SOFTWARE and shall continue until terminated. You may terminate it at any time upon written notice to Heinz Walz GmbH.

It will also terminate immediately if you fail to comply with any term of this EULA agreement. Upon such termination, the licenses granted by this EULA agreement will immediately terminate and you agree to stop all access and use of the SOFTWARE. The provisions that by their nature continue and survive will survive any termination of this EULA agreement.

Governing Law

This EULA agreement, and any dispute arising out of or in connection with this EULA agreement, shall be governed by and construed in accordance with the laws of Germany.
